WHEREAS, the Office of the Philippine Health Insurance Corporation of Pasig City issued a PHILHEALTH CIRCULAR No. 2017-0020 to the Accredited Health Care Institutions, Health Care Institution Service Banks and all other concerned for the implementation of Auto-Credit Payment Scheme (ACPS) to all Health Care Institutions;
