RESOLUTION EARNESTLY REQUESTING THE PROVINCIAL GOVERNOR HON. ROBERTO Y. UY, TO ALLOCATE FUNDS FOR THE EXPANSION OF SENIOR CITIZEN AND PWD BUILDING CENTER IN THE MUNICIPALITY OF PRESIDENT MANUEL A. ROXAS, PROVINCE OF ZAMBOANGA DEL NORTE, INTENDED FOR ITS CONFERENCE/ MEETING HALL

WHEREAS, as mandated by Republic Act 10070 An Act Establishing an institutional Mechanism to Ensure the Implementation of Programs and Services for Persons with Disabilities in Every Province, City and Municipality Amending Section 40 of Republic Act no. 7277, otherwise known as the Magna Carta for Disabled Person as Amended, and for Other Purposes, and in compliance with Memorandum Circular No. 2010-103 dated September 23, 2010 issued by the Department of Interior and Local Government and signed by the late former Secretary Jesse M. Robredo, the Municipality of President Manuel A. Roxas, Province of Zamboanga del Norte through its Sangguniang Bayan enacted and approved Ordinance No. 05, Series of 2014 Establishing the Persons with Disability Affairs Office in the Municipality;

WHEREAS, the office has become functional since last year and has been occupying a small building in which cannot cater the total number of the Senior Citizen and PWD;

WHEREAS, it is the desire of the Municipal Government to expand the said building to cater the Senior Citizen and the PWD during its conference and the said building will also serve as Productivity Enhancement Center for Person with disability in order to effectively deliver the programs and services for PWDs, however it cannot be expanded at this time due to insufficient funds of the Municipal Government catering to thirty one (31) barangays;

WHEREAS, considering the deep concern of the good Provincial Governor to the PWD sector, this August Body deems proper to address the resolution to the Honorable Roberto Y. Uy, Provincial Governor of Zamboanga del Norte;

WHEREFORE, viewed from the foregoing, and
On motion of Hon. Clayford C. Vailoces, mass seconded, be it

RESOLVED, as this Body does hereby resolve, to earnestly request the Provincial Governor Hon. Roberto Y. Uy, to allocate funds for the expansion of Senior Citizen and PWD Building Center in the Municipality of President Manuel A. Roxas, Province of Zamboanga del Norte, intended for its conference/meeting hall;

RESOLVED FINALLY, to forward a copy of this resolution to Hon. Roberto Y. Uy, Provincial Governor of Zamboanga del Norte, Capitol Building, Dipolog City, for perusal and approval;
