**RESOLUTION REQUESTING HON. MARK VILLAR, SECRETARY OF THE DEPARTMENT OF PUBLIC WORKS AND HIGHWAYS, THROUGH HON. GLONA G. LABADLABAD, REPRESENTATIVE, 2<sup>ND</sup> DISTRICT OF ZAMBOANGA DEL NORTE, TO ALLOCATE FUNDS FOR THE CONSTRUCTION OF FLOOD CONTROL SYSTEM OF BARANGAY PIAO ALONG UPPER STREAM OF PIAO RIVER OF THE MUNICIPALITY OF PRES. M. A. ROXAS, ZAMBOANGA DEL NORTE**

**WHEREAS**, during heavy rains, the water along Piao River will overflow that resulted to flashflood in which most of the livestock, crops and other properties of the residents living along the area are very much affected;

**WHEREAS**, it is this Body’s contention to request the Honorable Secretary of the DPWH through the Representative of 2<sup>nd</sup> District of Zamboanga del Norte for the construction of flood control system in the said area to avoid overflowing of water;

M. A. Roxas, Zamboanga del Norte;
