**RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR HON. JAN HENDRIK I. VALLECER TO  
NEGOTIATE AND ENTER INTO AN AGREEMENT FOR THE PURCHASE OF A PARCEL OF LAND  
OWNED BY ONE EVELYN SAMPIANO SITUATED AT SITIO BOLON, LOWER IRASAN, THIS  
MUNICIPALITY**

**WHEREAS**, the purpose of this resolution is to ratify the contract that has already been entered by the Municipal Mayor between this LGU and the landowner Evelyn Sampiano for the purchase of a parcel of land situated at Sitio Bolon, Lower Irasan, this Municipality;

**WHEREAS**, among other provisions stipulated under the said agreement that:

1. Seller shall undertake the processing of the Certificate of Registration (CAR);
2. Buyer shall pay:
  - a. The Capital Gain Tax (CGT);
  - b. The Documentary Stamp Tax (DST); and
  - c. Transfer Taxes

**WHEREAS**, the said property will be the site for the planned establishment of a Municipal Eco-Park;
