RESOLUTION REQUESTING THE DPWH SECRETARY HON. MARK VILLAR THROUGH HON. GLONA G. LABADLABAD, REPRESENTATIVE, 2ND DISTRICT OF THE PROVINCE OF ZAMBOANGA DEL NORTE, TO ALLOCATE FUNDS FOR THE CONSTRUCTION OF RIVER/ FLOOD CONTROL ALONG BOTH SIDES OF THE UPPER STREAM OF TANGIAN RIVER, BARANGAY LANGATIAN OF THE MUNICIPALITY OF PRES. M. A. ROXAS, PROVINCE OF ZAMBOANGA DEL NORTE

WHEREAS, the situation of the residents living along the bank of Tangian River is alarming during heavy rains, which floods destroying houses, livestock and other properties;
