RESOLUTION AUTHORIZING THE MUNICIPAL MAYOR HON. JAN HENDRIK I. VALLECERTO SIGN AND ENTER INTO A MEMORANDUM OF AGREEMENT (MOA) BY AND BETWEEN THIS LOCAL GOVERNMENT UNIT AS THE FIRST PARTY AND THE DIPOLOG SOUTHBOUND BUS/ JEEPNEY OPERATORS AND DRIVERS ASSOCIATION (DSBJODA), REPRESENTED BY ROGER PANAMA, RONILO ALTARIBA AND THE REGIONAL OPERATORS AND DRIVERS OF TRANSPORT ASSOCIATION (RODTA), REPRESENTED BY GODOFREDO S. AMARILLE, AS THE SECOND PARTY, WITH OFFICE ADDRESS AT DIPOLOG CITY, RELATIVE TO THE OBSERVANCE OF THE TRAFFIC REGULATIONS IMPOSED BY THE MUNICIPALITY OF PRES. MANUEL A. ROXAS, PROVINCE OF ZAMBOANGA DEL NORTE

WHEREAS, the FIRST PARTY shall strictly implement municipal ordinances concerning traffic regulations and issuance of citation tickets to all public to all public utility vehicles without discrimination; provide the SECOND PARTY space for parking on the Municipal Integrated Bus Terminal and make the amenities within the Municipal Integrated Bus Terminal accessible to the SECOND PARTY;

WHEREAS, the SECOND PARTY shall direct its members to observe the traffic regulations imposed by the FIRST PARTY throughout its territorial jurisdiction including regulations on bus stop and loading/unloading of passengers; direct its members to stop by the Municipal Integrated Bus Terminal when passing through the territorial jurisdiction of the Municipality of Pres. M. A. Roxas and direct its members to pay a terminal fee of Ten Pesos (Php 10.00) per day;

WHEREAS, based on the conditions between the DSBJODA, RODTA and this LGU, it stipulates the role of each entity which this Body found it reasonable to the contracting parties;
