**WHEREAS**, this resolution is prompted due to the condition of some ailments person in far flung barangays like Marupay, there is no midwives assigned especially to work and monitor in the health centers in Barangay Marupay, Tantingon and Sibatog of this municipality, such that in cases of emergency, instituting first aid to any ill fated persons is really a problem and a difficulty;

**WHEREAS**, this really the perception since the incidence of common ailments including minor accidents are indeed unpredictable;

**WHEREAS**, as a matter of looking into this situation, assigning stay-in midwives in the said barangay is very necessary to cure and assist the ailments of the constituents and it is a very practical manifestation of concern for their safety and welfare;

**WHEREFORE**, viewed from the foregoing, and

**RESOLVED**, as this Body does hereby resolve, to request the Municipal Health Officer Dr. Shaheeda T. Hassiman through the Municipal Mayor Hon. Jan Hendrik I. Vallecera, to assign permanent stay-in midwives during weekdays (Monday to Friday) in Barangay Marupay, this Municipality;
